#### MEMBERSHIP AGREEMENT INCLUDING FEE SCHEDULE

UCU's full membership agreement is available upon request by calling 800.696.8628. The following section is new and now effective within the membership agreement:


#### TERMINATION OR CURTAILMENT OF YOUR MEMBERSHIP RIGHTS AT THE CREDIT UNION

Membership at our Credit Union is a privilege granted to you by fellow members under state or federal law. You may end your membership with the Credit Union at any time by providing us with written notice of your desire to end your membership or in person at one of our branch locations. You understand that ending your membership does not release you of your responsibilities, obligations or liabilities to us under this agreement. A member may be subject to expulsion from the credit union for any of the following reasons: 1) Has not carried out member's engagement with the credit union; 2) Has been convicted of a criminal offense; 3) Neglects or refuses to comply with the membership agreement provisions of the credit union; 4) Has deceived the credit union or a committee of the credit union with regard to the use of borrowed money; 5) Has substantially and repeatedly violated the official policies of the credit union; 6) Has demonstrated dangerous, threatening or abusive behavior in such a way as to disrupt the operations of the credit union; 7) Has been convicted of fraud, attempted fraud, conspiracy to commit fraud or other illegal conduct in relation to the credit union, including illegal conduct in which an employee of the credit union was conducting business on behalf of the credit union. Management will inform an expelled member of the ground(s) for the expulsion, and the expelled member may appeal the expulsion to the Board of Directors. A decision by the board regarding an expulsion is final. All member limitation of service or expulsions shall be reported to the Board of Directors at the next regularly scheduled meeting.
